CARE Egypt Foundation for Development, registration no 833 for the year 2018 at the Ministry Of Social Solidarity in Egypt. CARE Egypt Foundation (CEF) is an Egyptian, non-governmental organization harnessing the legacy of CARE International in Egypt since 1954 to fight poverty and improve livelihoods. We envision Egypt as a place where everyone enjoys economic opportunities, equality and social justice. We empower women and girls by sharing our values amongst the private sector, government and civil society.

Women's Rights Program

The Women's Rights (WR) Program is designed to empower poor and marginalized women in Egypt who suffer from rights' violation. Its impact goal is: By 2025, poor women in Egypt especially in Upper Egypt are empowered and enjoying a better quality of life, having attained their rights. In order to achieve this goal, the program works with both the duty bearers in government and civil society, as well as rights bearers, women themselves, to address discriminatory attitudes and behavior towards women and girls.

The WR program works with the duty bearers to support their role to protect and uphold the rights of women, and also with the women to encourage them to understand voice and demand their rightful entitlements. The program works on three domains (agency, relations and structure) in order to empower poor women in Egypt to gain their rights. Through the focus on agency, women's self-esteem and confidence are built, and women have increased financial independence to fulfill their potential as productive and income-earning members of their households and society. In addition, when power relations (families) are gender sensitive whilst tackling all forms of gender-based violence (GBV) within and outside the household, and when structures (social norms or laws) particularly in the area of personal status, domestic violence are reformed, passed and implemented, gender equality can be achieved.

The program has three themes, which are:

- 1. Tackling Gender-based Violence (GBV).
- 2. Women's Social and Economic Empowerment.
- 3. Engaging Men and Boys (EMB).

<u>Safety, Empowerment and Protection for Syrian and non-Syrian Refugees and Host Communities in Egypt</u>

CARE proposes a 2-year project to create an enabling environment to change harmful gender norms thereby reducing SGBV and increasing child protection with interventions targeted at the individual, family, community and societal level. SGBV forms targeted include intimate partner violence, non-partner sexual violence, FGM, CEFM, and child sexual abuse and exploitation. Activities will follow CARE's COVID-19 Standard Operating Procedures (SOPs), and will take place in person, if possible, strictly adhering to safety guidelines, or will shift to virtual and alternative implementation methodologies. CARE's SOPs also ensure our programs uphold Sphere Protection Principles and Standards. A 2-year period is necessary to fully complete certain project components (i.e., livelihoods), further consult participants, and to build local authority capacities to take over the running of Women-Friendly Spaces.

Objective of the Assignment:



Fathers and Children, Single Mothers Camps:-

CARE will conduct a series of camps, designed in a fun and experiential way to encourage men's participation, to address positive parenting techniques and marital challenges and how, in many cases, they unfold to violence. Each camp will last for one day giving target families the chance to take some time away from their usually hectic schedules and reflect on their own attitudes and behaviors, as well as working on their own relationships. Some sessions will be conducted with parents separate from their children aiming to reflect on gender roles and parenting techniques within their households. At the same time, interactive activities will be held with children in order raise their awareness around child protection. Joint activities will also be held with parents and their children in order to explore positive parenting techniques. Camps are seen as another dimension of engaging men. The project will reach 24 families over an average of 8 camps.

So Care is searching for a consultant /consultancy firm that will Design and implement 8 camps by using Online & offline methods (blended), that would provide Refugees families knowledge around SGBV. The camp should utilize a gender transformative approach to challenge the men perceptions on norms and distorted definitions within the society around SGBV.

Each camp shall include interactive methodology and games aiming at attracting all members of the family (Parents and children). Each camp should include activities/sessions for parents separately, and for children separately, In addition to activities and sessions for both jointly.

Scope of Work

The consultants shall provide 8 Camps, Two in Cairo and another Two in Alexandria/Damietta for each category.

Regarding Fathers and Children camps; each camp will reach 12 Men and 2 kids per father each camp will last for only one day.

Single Mothers camps; each camp will reach 12 Mothers and 2 children each will be reached through 4 1-day camps with total 48 mothers average 2 kids per mother which is 96 children.

Duties and Responsibilities

Design and implement a camp program for refugees as follows:-

- Design and implement a camp program for Fathers, Children and Single Mothers.
 Design and implement camp educational, awareness materials that focus on the concepts of parenthood and dealing with children aiming at enabling participants to apply what they learn in their communities
 Design activities for children and parents to raise their knowledge around child abuse and child protection.
 Design and implement courses that focus on the concepts of parenthood and dealing with children aiming at enabling participants to apply what they learn in their communities
 Design activities to empower women and raise their knowledge around SGBV.
 Design activities to be held with parents and their children in order to explore positive parenting
- □ Design various activities to help the families to do positive practices to overcome stress.
- □ Increase awareness of the issues of SGBV and child protection among the refugee population living in Cairo and Alexandria/ Damietta.



□ Design the camps to include interactive activities and purposive games which are followed by reflection sessions.

Deliverables:-

- Design and conduct the camps
- Conduct pre and post surveys
- Photo and video graph the camps
- Submit a comprehensive report documenting the implemented activities, highlighting all participants' feedback, analysis and further actions to be taken.
- The activities should be innovative, and invite interaction and creativity.
- Provide the venue, meals, material, equipment per each camps

IMPORTANT NOTE:

- The consultant can submit a proposal for (Fathers Children and Single Mothers Camps), or only (Fathers and Children or Single Mothers Camps) or for CAI or Alex. camps only.
- CARE reserve the right to split the assignment on more than one consultant per gov. or per camp
- The consultant is responsible to abide by the instructions and guidance issued by the public

 measures and actions to apply the Do-No-Harm principle during the activity implementation
 and to assess the potential challenges that might happen due to this pandemic.
