Terms of Reference

Technical proposal writer



CARE Egypt Foundation (CEF):

CARE Egypt's Agriculture and Natural Resources Program (ANRP), in partnership with PepsiCo, is implementing She Feed the World (SFtW) project to improve the livelihoods and food security of 10,000 smallholder farmers in the Beheira, Giza, Beni Suef, and Minya Governorates. The project aims to empower these farmers to overcome economic challenges, improve food security, and produce high-quality potatoes using sustainable and climate-smart agricultural practices.

Objective of the Assignment:

The objective of this proposal is to engage a technical proposal writer to provide technical support to the SFtW project in the following areas:

- 1. Develop the capacity of ANR/CARE team on technical proposal writing.
- 2. Provide guidance and technical support on ongoing technical proposal.
- 3. Ensure proposals are persuasive and meet donors' requirements.
- 4. Work closely with ANR team on developing new proposals.
- 5. Provide technical expertise and insights on technical proposals and financial budget development.
- 6. Develop and write technical proposal that match goals of the organization.
- 7. Support in budgeting and cost analysis.

Scope of Work and Deliverables:

The technical proposal writer will be responsible for the following tasks:

- 1. Well oriented on organization and the program.
- 2. Conduct thorough research on funding opportunities and donor requirements.
- 3. Coordinating and supporting proposal development and work plans with the SFTW team.
- 4. Write persuasive proposal that improve efficiency of project objective, methodology and expected income.
- 5. Write clear, well-structured proposal that attract donor.
- 6. Provide constructive feedback that improve project and team quality.
- 7. Stay updated to proposal writing trends.
- 8. Providing advisory support to SFTW staff on proposal writing and tracking the development of the proposals through the process.
- 9. Provide weekly updates on the progress of SFTW proposal development.

DELIEVERABLES:

- Provide regular updates on proposal progress.
- Prepare all necessary documentation, including budget justifications, logical frameworks, and appendices.



- Proposal templates and writing guidelines.
- High-quality technical proposals that meet donor requirements.
- Regular communication with project team.

- Bachelor's degree in English, communications and Agriculture, at least.
- Proven experience in writing technical proposals for NGOs or similar organizations.
- Demonstrated success in securing funding through high-quality proposals.
- Strong understanding proposal development methodology.
- At least 5 years of experience in technical proposal writing.
- Demonstrated experience in designing and developing proposals and projects.
- Experience in the Food and Agriculture and Sustainable Industries.
- Computer proficiency in writing, design and editing software, with the ability to present complex technical information clearly and persuasively.
- Fluency in Arabic and English.

 - iii. A capabilities statement of the consultant organization and/or brief description of relevant (similar) consultancies that would qualify for this assignment. This statement should be included as a separate annex, in addition to the five-page proposal.
 - iv. Consultant CV
 - v. It should indicate a complete list of deliverables and a proposed time-frame.

2. Financial Proposal:

The financial proposal should include a breakdown of the cost elements to assist in determining the rationale of the given rates.
